They could be seen in news reports, often clad all in black with balaclavas covering their faces, demonstrating at the presidential inauguration, and on California college campuses protesting far-right speakers, and most recently, on the streets of Charlottesville, VA, protecting, among others, a group of ministers including Cornel West from neo-Nazi violence. (West would later tell reporters, "The anti-fascists saved our lives.") Simply, antifa aims to deny fascists the opportunity to promote their oppressive politics, and to protect tolerant communities from acts of violence promulgated by fascists. Critics say shutting down political adversaries is anti-democratic; antifa adherents argue that the horrors of fascism must never be allowed the slightest chance to triumph again. In a smart and gripping investigation, historian and former Occupy Wall Street organizer Mark Bray provides a detailed survey of the full history of anti-fascism from its origins to the present day — the first transnational history of postwar anti-fascism in English. Based on interviews with anti-fascists from around the world, Antifa details the tactics of the movement and the philosophy behind it, offering insight into the growing but little-understood resistance fighting back against fascism in all its guises.

#### THE HISTORY OF THE LEFT IN EUROPE, 1850-2000

Only in the wake of World War II were democratic frameworks secured, and, even then, it was decades before democracy truly blanketed the continent. Neither given nor granted, democracy requires conflict, often violent confrontations, and challenges to the established political order. They organized civil societies rooted in egalitarian ideals which came to form the very fiber of Europe's current democratic traditions. The trajectories of European democracy and the history of the European Left are thus inextricably bound together. Geoff Eley has given us the first truly comprehensive history of the European Left--its successes and failures; its high watermarks and its low tides; its accomplishments, insufficiencies, and excesses; and, most importantly, its formative, lasting influence on the European political landscape. At a time when the Left's influence and legitimacy are frequently called into question, Forging Democracy passionately upholds its vital contribution.

#### **REALPOLITIK**

#### **A HISTORY**

Oxford University Press Realpolitik is approaching its 160th birthday, though it has existed as a form of statecraft for centuries and is arguably as old as the conduct of foreign affairs itself. Associated with great thinkers from Machiavelli to Kissinger, it is deeply rooted in the history of diplomacy yet alsoremains strikingly relevant to debates on contemporary foreign policy in the Obama administration today. Despite the fact that Realpolitik has had something of a renaissance in recent years, however, it remains a surprisingly elusive notion, defying easy categorization. In this concise book, John Bew aims to address this gap, offering a history of the concept of Realpolitik in the English-speaking world: its origins as an idea; its practical application to statecraft in the recent past; and its relevance to the foreign policy challenges facing the United States and the future. Now most often associated with the conduct of foreign policy, Realpolitik has traditionally had pejorative connotations in the English-speaking world and sits uneasily alongside notions of "enlightenment," "morality" and "virtue." But it has also had its defenders, admirersand exponents, who regard it as the best tool for the successful wielding of political power and the preservation of global order. As such, Realpolitik has both successes and failures to its name, as Bew's comprehensive and even-handed overview displays. Bew begins by charting the evolution of the idea through the work of important thinkers or statesmen from Machiavelli, Cardinal de Richelieu, and Thomas Hobbes up through Carl Schmitt, Kissinger, and Dennis Ross. He then examines how Realpolitik has been evoked and operationalized in US and UKforeign policy during specific episodes in the twentieth century, looking at such cases as the overthrow of Iranian Prime Minister Mohammad Mosaddegh in 1953, and President Nixon's visit to the People's Republic of China in 1972 - often taken as the archetypal instance of Realpolitik in action. Bewthen uses this historical platform to look forward to emerging foreign policy challenges in a changing, multi-polar, geopolitical scene - in which Realpolitik and agile statecraft seems as important as ever. Suggesting that there is a uniquely Anglo-American version of Realpolitik, which reflects an attempt (not always a successful one) to reconcile Western ideological and moral norms with purely utilitarian conceptions of the national interest, Bew argues that a more accurate and sustainable version of Anglo-American Realpolitik is one that recognizes the draw Enlightenment values andideas. Directed at a broader audience of current policy-makers, legislators and commentators with an interest in foreign affairs, this is a brilliant introduction to an important topic from one of the field's rising stars.

### MUSSOLINI'S ITALY

Since the critical discourses I analyze indulge in flights of poetic fancy I distinguish in my discussion of this material between the Lifar-image (the dancer on stage and object of discussion by critics), the Lifar-discourse (the writings on Lifar as well as his own discourse), and the Lifar-person (the historical actor). This topic is further developed in the final chapter into a discussion of the so-called Baroque dance both as a historical object and as a motif of contemporary experimentation as it emerged in the aftermath of World War II (circa 1947-1991) in France. My discussion of neoclassicism begins in the final years of the nineteenth-century and carries us through the Occupation; I then track the Baroque in its gradual development from the early 1950s through the end of the 1980s and early 1990s. #### MUSSOLINI

A&C Black In 1945, disguised in German greatcoat and helmet, Mussolini attempted to escape from the advancing Allied armies. Unfortunately for him, the convoy of which he was part was stopped by partisans and his features, made so familiar by Fascist propaganda, gave him away. Within 24 hours he was executed by his captors, joining those he sent early to their graves as an outcome of his tyranny, at least one million people. He was one of the tyrant-killers who so scarred interwar Europe, but we cannot properly understand him or his regime by any simple equation with Hitler or Stalin. Like them, his life began modestly in the provinces; unlike them, he maintained a traditional male family life, including both wife and mistresses, and sought in his way to be an intellectual. He was cruel (though not the cruellist); his racism existed, but never without the consistency and vigor that would have made him a good recruit for the SS. He sought an empire; but, in the most part, his was of the old-fashioned, costly, nineteenth century variety, not a racial or ideological imperium. And, self-evidently Italian society was not German or Russian: the particular patterns of that society shaped his dictatorship. Bosworth's Mussolini allows us to come closer than ever before to an appreciation of the life and actions of the man and of the political world and society within which he operated. With extraordinary skill and vividness, drawing on a huge range of sources, this biography paints a picture of brutality and failure, yet one tempered with an understanding of Mussolini as a human being, not so different from many of his contemporaries.
